Parental Waiver and Release of Liability for Ice Skating Rink Use PLEASE READ CAREFULLY

I, the undersigned, parent or legal guardian, acknowledge the inherent risk involved in ice skating, and all sports relating thereto. Accordingly, in consideration of myself, or my child(ren) being allowed to participate in any skating activities and/or other activities at Heartland Christian Academy, I agree to the following:

1. I acknowledge and fully understand that my child(ren) will be engaging in activities that involve risk of serious injury which might result not only from my child(ren)'s actions, but also from the action, inaction or negligence of others; and further, that there may be risks not known to me or not reasonably foreseeable.
2. On behalf of my child(ren), I agree to assume all the foregoing risks and accept personal responsibility for my child(ren)'s damages following such injury.
3. On behalf of my child(ren), I release, discharge, waive and covenant not to sue Heartland Christian Academy and all their respective agents, affiliates, associates, officers, directors, owners, and employees (collectively releases) from demands, losses or damages on account of any injury, death or damage to property, caused or alleged to be caused in whole or in part by releases or any other party's actions, inaction, or otherwise; and agree to indemnify releases from any and all third party claims caused in whole or in part by my child(ren)'s actions.
